

ENGLAND BOXING ANTI-DOPING RULES

- 1. The Board of England Boxing hereby resolves that the anti-doping rules of England Boxing contained in the England Boxing Anti-Doping Policy of October 2014 are repealed and replaced by the following rules.
- 2. The following rules have been adopted by England Boxing and are to be considered as the Anti-Doping Rules of England Boxing:
 - (i) The UK Anti-Doping Rules published by UK Anti-Doping Limited (or its successor), as amended from time to time; and
 - (ii) The AIBA Anti-Doping Rules.

(together the "England Boxing Anti-Doping Rules")

- 3. In the event of any inconsistency between the AIBA Anti-Doping Rules and the UK Anti-Doping Rules, the AIBA Anti-Doping Rules shall prevail.
- 4. The England Boxing Anti-Doping Rules are binding on the following persons or categories of persons:
 - a. Individual and Club Members of England Boxing (for a period of twelve months from the beginning of their membership and for a further twelve months thereafter upon each renewal);
 - b. The parents/guardians of Individual Members of England Boxing who are under the age of 18 (for a period of twelve months from the beginning of the Individual Member's membership and for a further twelve months thereafter upon each renewal);
 - c. Any individual who is, in any way, actively involved in Olympic (formerly Amateur) boxing in England, even if that individual is not an Individual Member of England Boxing;
 - d. Employees of England Boxing; and
 - e. Any person or body that is contracted to or by England Boxing (or any Associate or Club Member of England Boxing) for the duration of that contract.
- 5. Any breach of the England Boxing Anti-Doping Rules will be dealt with as follows:
 - (i) Any breach by Individual or Club Members; the parents or guardians of Individual Members under the age of 18; or any non-members who are actively

involved in Olympic boxing, will be dealt with in accordance with the relevant provisions of the England Boxing Anti-Doping Rules;

- (ii) Any breach by an employee of England Boxing will be dealt with in accordance with the procedure set out in the Staff Handbook; and
- (iii) Any breach by any person or body that is contracted to or by England Boxing (or any Associate or Club member of England Boxing) will be dealt with in accordance with the terms of that contract.
- 6. Any act or behaviour which is in any way connected with anti-doping but which does not in itself amount to an Anti-Doping Rule Violation (as defined in the England Boxing Anti-Doping Rules) may give rise to separate disciplinary proceedings for a breach of the England Boxing Code of Conduct.
- 7. England Boxing can refuse, terminate or suspend the membership of any Member at any time, and in its sole discretion, for any infringement of the England Boxing Anti-Doping Rules.
