The Chairman's Report

Welcome to the 2023 AGM

Dear Members,

With a full year as your Chair behind me, I am proud to present our report to the AGM at a time when England Boxing is doing well and the sport of boxing is in good shape. As ever we have many challenges, but working with the support of our excellent board, staff and volunteers is a rewarding experience and we are seeing good progress on many fronts.

Most importantly the interest in boxing in England is breaking records and we now have over 1,000 member clubs and 27,000 registered boxers up and down the country, these both being the highest numbers we have ever recorded. We are also experiencing an unprecedented demand for our coaching courses, and we are working hard to recruit additional tutors to be able to run sufficient courses.

Our restructured talent and pathway programme is very busy, and the England international successes are the reward of the hard work of our boxers, coaches and our strong club basis.

A new initiative that I very much enjoyed this year was the introduction of the Annual Awards Ceremony 2023 in July, crowning ten award winners in a wonderful celebration of amateur boxing and its heroes. The ceremony was held at the Crowne Plaza Royal Victoria Hotel in Sheffield and celebrated the stellar work performed by individuals and clubs who continue to inspire and transform lives through boxing. We will now make this an annual event and I encourage members to attend, it is a truly inspiring experience.

Many congratulations to our award winners and we know that they represent just a small part of the many volunteers that put in so much effort into the sport, working day in and out behind-the-scenes to make it all run so effectively. We know that this is the real heart of boxing in the community and so we have now introduced a successful new volunteer recruitment campaign to support clubs and strengthen the workforce for boxing.

Another of our many new initiatives in the England Boxing strategy is the apprentice's scheme that ran for the first year, giving ten young people from disadvantaged backgrounds an opportunity to start a career in boxing. A highlight was showcasing the scheme in the Copper Box Arena in October 2022 with Prince William as a special guest who donned the gloves and received some coaching from the England Boxing team – giving us plenty of strong and welcome positive media coverage.

Away from home, we received news that our international governing body, the IBA, has finally lost its recognition by the International Olympic Committee and this seriously threatens boxing's Olympic status in the future. We have long had issues with the IBA and its governance and leadership, and so we are taking steps to join World Boxing, the new body that has been formed by like-minded nations who wish

to keep boxing Olympic. This will pose many challenges and some considerable upheaval in the short term, but I believe that it is worth it for the future of the sport to keep the Olympic dream alive.

I wish to thank all our volunteers in Clubs and Regions, our coaches, doctors, as well as the dedicated staff of England Boxing for their hard work that has kept the sport going and for supporting our boxers so that they can continue to enjoy taking part in the sport. They are the ones that serve and delight our boxers every single day. They are the ones who show incredible commitment, passion, and resilience in times of continued uncertainty.

I am extremely proud to be part of this winning team. Together, we are England Boxing – supporting the infrastructure of boxing in England. We wish you all well for the coming year and once again thank you for your support.

England Boxing Chief Executive's Report

The last 12 months have been a time of significant change and restructuring at the Sheffield headquarters of England Boxing. Many new staff members have joined us, and we have adapted the professionalism of the organisation quite a bit to be ready to deliver the strategy that we adopted last year.

The focus has been on reviewing working practices, to continue what is going well and to change where we can improve. The enhanced investment by Sport England means we can deliver a better service for our members and develop the sport at a grassroots level, but also in the talent pathway programme at the elite level too.

Responding to the independent review of England Boxing, we have made significant improvements in the governance structure, with new policies and noticeable new practices in the area of compliance and safeguarding.

As for the future, we will now completely focus our efforts on executing our strategy, which we launched in 2021. Our plan is aimed at growth and investment in the future, paving the way for England Boxing to achieve future success. Our strategy is deeply rooted in the sport of boxing and puts the boxer at the heart of everything we do and is being brought to life by our boxing community. Our strategic focus is on increasing participation but also elevating the experience for the boxers and pushing the boundaries in our diversity, equity and inclusion journey with initiatives that are groundbreaking.

We have demonstrated our resilience and worked hard to support each other on an unpredictable journey in Covid times. But as that is now behind us, I can confidently say that the 22/23 season was a much better period than 21/22. On the back of successful vaccination campaigns around the globe, the worldwide economy started to recover, and sport has returned to the global stage, with the Commonwealth Games in Birmingham taking place, creating huge excitement around the success of the England Boxers.

This report gives an overview of our progress over the past year.

England Boxing Strategic Plan

The organisation is now halfway through the second year of our 5-year strategic plan (2022 – 2027) with a vision to '[Inspire & Transform Lives through Boxing](#)'.

With thanks to the additional capacity, resources and staffing made available through our primary partners at Sport England, our progress and pace of development within the organisation (in line with our strategic objectives) has been exemplary.

Below are just some of the highlights from the last year that have been delivered as part of England Boxing's key strategic objectives:

A thriving boxing community:

- Delivery of x9 club resilience training conferences across the country, benefitting 50+ clubs to advance their sustainability & governance with thanks to our partners at Sported, UK Coaching, and Club Matters.
- Roll-out of the 'Clubs in Crisis' Fund supporting 28 clubs who were in dire need as a result of post-Covid and cost of living price increases during the Winter of 2022-23.
- Increased membership numbers reaching 1,000-plus clubs and 27,000-plus members.
- Roll-out of the £250,000 'Together Fund' supporting 75 clubs to deliver projects supporting under-represented groups.
- The first-ever England Boxing annual awards ceremony was held in July 2023 with 10 volunteers being recognised for their efforts and dedication to the sport.

An inclusive, diverse and accessible sport:

- The 'Clink to Club' programme continues to be delivered within 2 prisons, and funding secured for an ambitious expansion of delivery across the country in 2024 to benefit clubs, members, and under-represented groups alike.
- EB Apprenticeship programme continues with seven young people due to complete their studies and move onto new career opportunities in November 2023, and a further three apprentices having recently been employed for year two of the programme's delivery.
- EB's inaugural EDI Conference was delivered in July 2023, as well as, the second annual Women in Boxing Conference in December 2022 alongside the Women's Winter Box Cup.
- Year 2 of the Inclusive Activity Programme is in progress with 40+ clubs delivering disability inclusion sessions nationwide.
- Year 3 of the Female Coach Development programme and year 2 for the Women's Officials Development programme are now well underway.
- Women's Aspire continues to offer women & girl's opportunity at national level, whilst the recent introduction of Women's Inspire provides similar opportunities to those at club & regional level.

An inspirational and aspirational competition and talent pathway:

- The launch of the Senior Performance Pathway in early 2023.
- The new Level 3 Coaching Course is a resounding success with cohort one participants now reaching the halfway point of their training, and applications received for cohort 2 due to start in April 2024.
- EB's most successful season on record with 45 international medals secured in 2022-23.
- The continued delivery of Open Talent Days to ensure boxers are given the best opportunity to represent their country.

A respected and valued NGB

- EB has a record number of followers and subscribers across all social media platforms, most notably Tik Tok which has tripled since last year.
- The recent modernisation of our safeguarding & compliance policies and procedures ensures that we are able to safeguard our members and sport with the most up-to-date practices.
- Sponsorship continues with our partners at Sting, ActiPH, CB Protection and Unibox.
- New partnerships have been created with the likes of BOXXER, Boxwise and Rematch Live, with others also due to be announced in the coming months.

The projects and work being undertaken by England Boxing as part of our strategy are regularly used as examples of best practices by partners and other NGBs alike, which is something that our staff and volunteers should be incredibly proud of.

We will strive with the continued ambition to develop and advance our sport so that it can inspire & transform more lives for many years to come.

National Championships

Throughout the previous season, all 10 England Boxing Competitions & Events were successfully delivered, resulting in the crowning of 362 National Champions from October 2022 to May 2023. Within these England Boxing Competitions & Events, there were a total of 569 female participants and 1,235 male participants.

The England Boxing inaugural Awards Evening was a resounding success as it recognised and celebrated the remarkable accomplishments and contributions of individuals, clubs, and organisations to amateur boxing. Held on 13th July 2023, at the Crowne Plaza Royal Victoria Hotel in Sheffield, the event hosted more than 100 guests and featured 29 nominees across the 10 award categories.

The weight categories for the England Boxing Championships have been reviewed in preparation for the upcoming 2023-2024 season. Minor adjustments have been made to the National Schools Championships, specifically involving the addition of Class A & B male U75kg categories (aligning them with the EUBC categories), and the removal of Cadet's male and female U68kg and U72kg categories in response to limited participation over the past few years.

Starting with the 2023 Development Championships, England Boxing will initiate a trial of an online ticket sales platform for future Championships and Events. This trial aims to bring several potential advantages, including:

- Precise resource planning and efficient venue arrangements.
- Strengthened partnerships with host venues.
- The capability to leverage customer data for valuable feedback.

- Accurate management of guest arrivals and guest lists.
- Improved event promotion and the opportunity to offer additional items such as merchandise.
- A streamlined entry process with minimised risks associated with payment handling.

The England Boxing 2023-2024 Competitions & Events calendar will soon be communicated to our members, along with the official confirmation of locations and host venues for the later stages of each Championship.

The conclusion of England Boxing's 2022-2023 Championship season is a fantastic achievement and a testament to the dedication and hard work of all boxers, coaches, clubs, regions, officials, volunteers, and England Boxing staff who made these events possible. We are very much looking forward to developing the events offering in 2023-2024.

Our Online Presence

England Boxing platforms have continued to grow over the last 12 months which enforces the fact that we are a respected and valued NGB.

We tend to cover a number of different demographics across all (Facebook, Twitter, Instagram and Tik Tok) and have picked up a few key learnings over the last season.

With the majority of the coaching community being present on Facebook, it is vital that we continue to share updates on the platform. It has grown from 66,000 to 68,000 followers during August 2023 with the most popular posts gaining 16k and 1.8k likes. Both featured prominent boxers during international tournaments – this highlights that the athletes need to be utilised more often and treated like ambassadors/influencers if we want to continue to grow. The website still serves as a hub of information for our community to find any updates on courses, rules, club information and case studies.

Event coverage seems to make the most impact and with the performance programme competing more often internationally, this has resulted in an increase of followers during our off-season. In August 2023, the EB Instagram following grew from 69,600 to 71,900 in a short period of time. This shows that there is a keen interest in what occurs at tournaments both in the ring and behind-the-scenes. We'll look to build on this for the upcoming season.

The EB Tik Tok has gone from strength to strength and has accumulated a following of 128,600. In contrast to the other platforms, this has demonstrated that there is a Gen Z audience ready to engage with us in a light-hearted manner. The most popular post had 20.5M plays from May 2022 and was a clip of a teenage boxer celebrating a win paired with trending audio. Moving forward, we'll be aiming to get more entertaining content at domestic events as this is what really connects with our audience.

A modern approach will also be applied to the England Boxing guidelines in order to retain younger audiences (both in terms of the tone of voice along with the overall look and feel).

Workforce

The workforce department have made significant changes to the structure that underpins qualifications over the past 12 months since August 2022.

Firstly we are almost half way through development of the participation development model (profiling the participants we deliver to), and the coach development model (the coaches we need to deliver to the participants). This work is hugely important in effectively being able to develop appropriate qualifications and CPD support.

We have also completely reworked the coach educator model, with the introduction of a tutor/assessor accreditation programme which outlines skills required for the job and alongside this an associated contract for services delivered. This is to ensure professional conduct and delivery of our qualifications. We have now moved into assessing all coach educators to ensure they have all the qualifications and minimum operating standards for being a coach educator, and they will be issued with an England Boxing lanyard to wear when delivering that will need to be updates every 12 months.

We have recruited from our existing network 2 lead tutor trainers to support the recruitment and delivery of new Level 1 and 2 tutors. We have recruited another 25 prospective tutors to start a Level 1 tutor training process from September 2023, and we have 3 tutors to start training to become a Level 2 tutor at the same time.

Level 1 – From January 2022 – December 2022 there were 96 courses delivered to 821 candidates. So far from January 2023 – July 2023 there have been 51 courses delivered to 871 candidates.

Level 2 – From June 2022 – December 2022 there were 9 courses delivered to 126 candidates. So far from January 2023 to July 2023 there were 14 courses delivered to 199 candidates

Level 3 – The level 3 senior coaching programme restarted delivery in April 2023 with 30 candidates taking part. This was coaches who were recruited prior to the new workforce team being in place and numbers will reduce from April 2024 to ensure quality of delivery. Recruitment is currently in progress with applications closing on 31st August 2023. Delivery of the next cohort due to start April 2024.

Membership and Members

The 2022-23 season seen our membership grow from strength to strength, with the number of affiliated clubs rising to 1014 and membership to 26,500 which see's our sport in a stronger position than ever. The support provided by regions, clubs, officials, coaches, boxers and volunteers has been immeasurable, and continues to unite and build our expanding boxing family.

The Vault is England Boxing's Membership application and information centre, is continuing to be developed to enhance the membership experience and will share further details of new and updated features in the coming months.

Our Mental Health support continues to expand with the Box In Mind courses, regular website content and a monthly newsletter with useful content to support our boxing community.

As part of the continued improvement to safeguarding our sport and supporting our clubs, from 1st July 2023, all doctors were required to affiliate on The Vault and wear a doctor's ID card and lanyard at all times when supplying medical assistance.

The Medical Sub-Committee have started a ringside doctor training courses for new doctors interested in becoming ringside doctors. This will be offered to all existing and new doctors, either as a CPD opportunity or a general opportunity to refresh knowledge of supplying boxing medical assistance.

Over the past year, we have seen significant progress and successes within our team, both in terms of medal results and the development of not just our athletes but our coaches and staff as well. Following a record breaking 2022 in terms of medal success ([detail](#)), the EB performance pathway have continued to be at the forefront of medal winning internationally. In 2022 we achieved 45 medals from 5 major competitions (average 9), which compares directly to our current year (2023) where we have claimed 35 medals from only 3 competitions (average 11.6).

In addition to this we have also extended the international competition opportunities for our pathway boxers. Resulting in 22 boxers representing EB and winning 18 medals so far, with more to come this year. Furthermore, three nation events and international duals have seen us win each event we have attended and more importantly provide unprecedented competitive exposure to our athletes. Something which is vital in us creating the most inspirational and aspirational talent pathway possible.

It is worthwhile to pay specific mention to the newly formed senior programme, which was successfully scoped, piloted and launched. A highlight being 2 of the athletes being selected to become part of the GB WCP recently. Thus, showcasing the power of the programme in filling a void in which boxers have no programme and deterring them from quitting the sport or turning professional.

The pathway was revised in the first part of the year with a simpler format of performance and development programmes for each age group. This, along with the new simpler routes onto pathway can be found in our newly developed handbooks ([link](#)). This revised pathway has also been supported with the introduction of sports science support on the pathway. Recruiting a consultant sports science lead has made sure we have pitched the appropriate support at the right opportunities to make sure we get the best impact. This has included support around Nutrition, S&C, Physiotherapy, Performance Analysis and Psychology.

Furthermore, in supporting our boxers, our application for DiSE places received a fantastic allocation of 100 learners. All SportsAid nominations put forward were also successful, meaning 13 boxers have directly received funding to help towards the cost of excelling in boxing. In addition, all 8 Backing the Best (BTB) nominations were also successful in gaining funding. Therefore, a total investment of over £50,000 to date has been made to 21 nominated England Performance Boxers. Alongside this, all senior boxers have been granted TASS support.

Coach development has been firmly on our radar this year and recruitment taking place to make sure we had the cover required to carry out our ambitious activity plans. We currently have 27 coaches who are IBA 1 Star qualified, prior to November 2022 we had only 3. We also have 10 pathway coaches currently undertaking UK coaching courses which is an impressive achievement.

Financial

From a financial perspective, England Boxing recovered well from the £48,992 loss sustained in 2021 due to COVID-19 which was the biggest loss since 2017, the following financial year in 2022 finished on a breakeven level. Breakeven is the aim as spare resources are all invested in the community and the future of the sport. Sport England supported England Boxing and the boxing community throughout the pandemic and continue to do so by increasing the funding allowing England Boxing to carry out the agreed strategy up to 2027.

The latest challenge is to navigate through the current inflation and cost of living crisis which is putting a tremendous amount of pressure on England Boxing's ability to carry out the day to day functions without reducing the quality of service or adjusting operational expenditure. The finance department continues to work closely with the other departments with the focus on efficiency, effectiveness and "how to do more with less".

Governance

England Boxing is set up as a Company Limited by Guarantee and not having share capita Company No 02817909 with its registered office at Coleridge Road, Sheffield, S9 5DA. The Company is run by an independent Board of Directors and we are committed to working in accordance with the principles of governance as set out in the (revised) Code for Sports Governance.

BDO Audit: England Boxing is a Sport England funded partner. Our Funding Agreement sets out that we can be selected for an independent review. Sport England have commissioned BDO In July 2022 to undertake a Governance Review and a report was finalised in January/February 2023. The Board is currently implementing the remaining recommendations from the report.


The Board of Directors met 7 times during the year 2022. At the 2022 July meeting the required quorum was not present and the meeting was officially adjourned, but informal discussions continued. The minutes of the Board are published on the England Boxing Website.

Clean Sport

There have not been any Adverse Analytical Findings (AAFs) (a positive test for a Prohibited Substance or a Prohibited Method) or any Anti-Doping Rule Violations (ADRVs) (a finding by a panel that a person has committed a breach of the anti-doping rules) by an EB member.

There have been no reports to, or information received by, the Compliance Manager of any active anti-doping investigations. It should be noted that UKAD and other regulatory bodies take the confidentiality of their investigations seriously and are unlikely to inform any NGB other than at the conclusion of an investigation. UKAD reported 8 IBA commissioned tests on UK based Boxers, likely to include GB Boxing members, but included in the GB Boxing Programme and not under the England Boxing pathway.

In addition, 77 Out of Competition Tests were reported under GB Boxing, which again, will have included England Boxing members in the GB Boxing Programme.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2022

1. STATUTORY INFORMATION

England Boxing Limited is a private company, limited by guarantee, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary assets in these financial statements are rounded to the nearest pound.

The principal accounting policies adopted are set out below.

Going Concern

In common with virtually every other business in the country, the Company has been experiencing the effects of the Coronavirus pandemic. Whilst the full impact of this exceptional situation on the Company cannot be assessed with complete certainty at the current time, the Directors believe they have taken all possible steps to protect the Company including accessing relevant Government assistance.

At the time of signing these accounts the Directors are of the opinion that the Company will remain viable for the foreseeable future and therefore these Financial Statements have been prepared on the Going Concern basis.

Turnover

The income of the company consists of clubs' and individual's affiliation/registration fees, grants and donations, together with monies raised from tournaments and the sale of goods towards running boxing events.

Affiliation and registration fees are payable annually, are accounted for when notified by the individual clubs that they are due and deferred to the extent that the affiliation income relates to the following financial year.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Plant and machinery	25% on cost
Fixtures and fittings	20 - 25% on cost

Taxation

Taxation for the year comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

NOTES TO THE FINANCIAL STATEMENTS - continued FOR THE YEAR ENDED 31 MARCH 2022

2. ACCOUNTING POLICIES - continued Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the year end and that are expected to apply to the reversal of the timing difference.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

Pension costs and other post-retirement benefits

The company operates a defined contribution pension scheme. Contributions payable to the company's pension scheme are charged to profit or loss in the period to which they relate.

Honorarium

An honorarium is an ex gratia payment made to a person for their services in a volunteer capacity, or for services for which fees are not traditionally or legally required.

An honorarium is typically a payment made on a special or non-routine basis to an individual who is not an employee of the company, to recognize or to acknowledge the contribution of gratuitous services to the company.

Operating leases

Rentals paid under operating leases are charged to the profit or loss on a straight line basis over the period of the lease.

Judgements and key sources of estimation uncertainty

In the application of the company's accounting policies, the directors are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

3. EMPLOYEES AND DIRECTORS
