# Ashfield Spartans Boxing Academy:

- 1. Q: Handling of Complaints and Disciplinary Processes Reply Board Member James Stebbing: AGM is not the forum to discuss individual cases. Also, this subject is still part of ongoing complaints procedure, so again, not the time and place to discuss.
- 2. Q: Victimisation for Holding the NGB to Account Reply Board Member James Stebbing: This question refers to a specific case, for which the AGM is not the place to discuss.
- 3. Q: Affiliation with International Governing Bodies: IBA and World Boxing Reply Chair EB Richard Brooke: Richard explained the direction we are travelling. England Boxing is a founding member of World Boxing and active in it's committees and even has applied hosting its events. As World Boxing is developing and growing, we believe that given the reputation and expulsion from the IOC, we as England Boxing will have to consider leaving IBA. World Boxing has a Rule Book and England Boxing will ensure that the transition will be as seamless as possible.
- 4. Q: The England Boxing Database the Locker and Upcoming Matchmaking Database Reply Board Member Sam Foster: There is no plan at this moment to charge for this service.
- 5. Q: England Boxing Employment and Recruitment Practices Reply CEO Jerome Pels: England Boxing follows strict fair recruitment policies aimed at a fair process of recruiting compete staff. There is no 'targeted' group. We are actively inviting and encouraging as wide as possible to apply for roles at England Boxing. Two recent hires have been from the boxing community as an example.
- 6. Q: Handling of Regional Association Discipline Reply Board Member James Stebbing: Again we seem to be talking here about a specific case. The AGM is not the place to discuss specific disciplinary cases.
- 7. Q: Progress on Outlawing White Collar and Unlicensed Boxing Reply Head of Operations Avoen Perryman: There have been some developments. We are aware there is draft legislation in the making which is currently awaiting a consultation process that needs to be initiated by the government. The Elections and change of government have delayed progress on this matter.
- 8. Q: The Split in Scottish Amateur Boxing Reply Chair EB Richard Brooke: We are supporting Boxing Scotland, and our present stance is that our clubs should only be competing with Boxing Scotland affiliated clubs.
- 9. Q: Gym Inspections and Compliance with Health and Safety Standards Reply Head of Operations Avoen Perryman: The Community Department are aiming to visit all 1,070+ clubs by June 2025 to support them in meeting safety and governance standards in-line with EB's Club Membership Policy.
  - Clubs are RAG rated and can be given anything from 3 12 months to update any issues that are flagged depending on their risk level, and CSO's will be on-hand throughout that time period to help and support the club to meet those requirements.

#### Denise Coe:

Who will have access to the matchmaking database? Will there be limitation for safeguarding reasons? Reply CEO Jerome Pels: We haven't worked out the details of that will work, but we have different levels of access linked to specific roles in the Club or Region.

# Janet Vitti (Bad Boyz Boxing Gym – East Midlands):

We are having issues with British Boxing Board of Control rules insisting amateur experience before becoming professional. Those boxers not actually come to the clubs and train in the clubs, just register for the formality. Reply CEO Jerome Pels: No direct answer, but we have a good relationship with the British Boxing Board of Control and certainly make a note or your comment.

The meeting was called to order after the allotted waiting time of 1 hour.

Eric Lee the Head of Finance outlined the company financials, as detailed in the annual report and how income and expenditure has developed over the recent years.

Comment from the floor: Ritchie Fox (Ashfield Spartans – East Midlands): I note the loss we are making. What about bringing back sanctioning title belt series? England Boxing can charge and generate additional income?

All present were asked to adopt the 2022/2023 accounts, and all in attendance approved.

England Boxing had not received any resolutions or proposals for resolutions, and so therefore there was no need for a vote on this particular agenda item.
